Pass Protection Plan

The Pass Protection Plan, at a cost per individual of \$40, will cover the prorated (based on the available skiing/riding days up to the date of incident) cost of your Season Pass in the event of Injury, sickness or death of a Passholder preventing participation in the sport. Claims must be made within 45 days of the incident.

Conditions apply – please contact our Guest Relations office or visit our website at cypressmountain.com for details.

Important – other than the conditions covered by the Pass Protection Plan, your Season Pass is non-transferable and non-refundable under any circumstances.

Conditions of Sale

As a Season Passholder at Cypress Mountain, I understand and hereby agree to the terms and Conditions of Sale as follows:

1. I will OBEY all warning signs and other notices posted within the Ski Area and facilities and OBEY the Alpine/Cross Country Skier's Responsibility Code.
2. The Pass remains the property of Cypress Mountain. My Season Pass once issued, may be subject to CANCELLATION OR REMOVAL by Cypress Mountain without refund at its sole discretion. The privileges and services the Season Pass grants may be revoked in the event of misconduct, fraudulent use of the Pass, failure to observe posted notices or warnings, or failure to obey the Alpine/Cross Country Skier's Responsibility Code.
3. Season Pass holders shall be responsible for any misuse of the Pass, whether or not the misuse occurred with the Pass Holder's knowledge or consent. Season Pass holder is RESPONSIBLE FOR PROPER USE OF THEIR SEASON PASS AT ALL TIMES.
4. Age is as of November 1st, 2011 for season passes bought prior to Nov. 1st, 2011. Passes purchased after this date are sold according to current age; proof of age will be required at time of pass processing.
5. Cypress Mountain has the right to REFUSE ADMISSION to any of its skiing or service facilities.
6. In the event that I forget my Season Pass, a day ticket will be issued to ski that day from the Guest Relations department in the Sales and Information Office. (This courtesy is offered ONCE per season. Tickets will have to be purchased for subsequent occurrences).
7. If I lose or break my Season Pass, I will notify Cypress Mountain immediately, and if the pass is not found, I will be required to pay a \$30 REPROCESSING FEE.
8. A \$30 fee will be charged for RETURNED CHEQUES.
9. I will present my Season Pass for inspection UPON REQUEST.
10. Once purchased, my Season Pass is NON-TRANSFERABLE AND NON-REFUNDABLE, under any circumstances.
11. I have read, understand, and I have signed or will sign the RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS, AND INDEMNITY AGREEMENT. I also understand that my Season Pass will not be issued to me if the Agreement is not completed in full, dated, signed, and witnessed. (Persons 13 and under will require the signature of a parent or legal guardian).
12. Season Passes are valid for the Winter 2011-2012 Season, expiring at season's end on or before April 30, 2012.
13. No Compensation shall be granted in the event of an unused Season Pass.
14. Pass Protection may only be purchased at the time of Season Pass purchase.
15. Once purchased all sales are final. No compensation will be granted for any product that has not been picked up.

16. I will present my Cypress Gold Medal Card at the Alpine or Nordic Ticket office to receive my FIRST one (1) free lift ticket and I will present my Cypress Gold Medal Card (along with photo ID) on subsequent days in order to receive my discount on my Full Day rate, Evening rate (starting at 4pm), or Nite Owl rate (starting at 7pm).
17. Nordic Gold Medal Card only valid in the Nordic area and Alpine Gold Medal Card only valid in Alpine area.
